<b>Data Protection Laws</b>	any applicable law relating to the processing of personal Data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;
<b>GDPR</b>	the General Data Protection Regulation (EU) 2016/679;
<b>BFTCI, we or us</b>	Brain Food TCI
<b>UK and EU Cookie Law</b>	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;

## Scope of this privacy policy

3. This privacy policy applies only to the actions of BFTCI and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
4. For purposes of the applicable Data Protection Laws, BFTCI is the "data controller". This means that BFTCI determines the purposes for which, and the manner in which, your Data is processed.

6. We collect Data in the following ways:
- a) data is given to us by you; and

## **Data that is given to us by you**

7. BFTCI will collect your Data in a number of ways, for example:

## Our use of Data

9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:

## Data retention

## Your rights

17. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b) **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
  - c) **Right to erase** - the right to request that we delete or remove your Data from our systems.
  - d) **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.
  - e) **Right to data portability** - the right to request that we move, copy or transfer your Data.
  - f) **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.
